I. Call to order

President Mikel Knepley called to order the regular meeting of the Town of Greensboro at 6:32PM on April 4, 2022, at Greensboro Community Building.

III. Approval of minutes from last meeting

Minutes from the March meeting were read and same were approved by the board.

IV. Open issues

1. Paving/Patching Roads: Paving is complete. Grant recertification for North side has been submitted. Town portion approximately \$37,000. Possible send a letter requesting donations/pledges. Party with Kevin Stonerock (summer sometime). GMC would like to work with the community to have a party.

Need an interim fix to the potholes. Jason Clark would like to possible help with taking the millings. Possible take out a bond to help pay for repairs.

2. Ordinances/Bylaws. Town Board agreed to revisit the town ordinances/bylaws. Town will go through the ordinances/bylaws and then bring them up before a town board meeting.
3. Police Department update. Caliber (software for CADS). Way too expensive, so police department going different way. Sheriff is still not responding – won't associate with Greensboro. Deputies will be working starting April (1 officer). In May (2 officers).


4. Greensboro Community Fund. Easter event April 16, 2022, beginning at 1:00 PM. All officers will be present. Sponsorship of Easter Baskets. 900 eggs to find. 24 Golden Egg will result in a basket.
5. Internet. Installed and ready for use.
6. Audit. Audit completed. Few things to tidy up but went well. Matter closed.

V. New business

1. Salary Ordinance. The board and Clerk-Treasurer will continue with the same salary in 2022 as previously adopted. Board approved salaries stay the same unanimously.
2. Capital Asset. What amount does an asset become a capital asset? \$5K-\$10K? Capital asset includes community building, vehicles, roads, anything over cap amount. Board approved a cap of \$7500 for capital assets.
3. Federal Field Services. Is the Board interested in purchasing plan? Board approves to use the Maintenance Inspection Plan for \$500.
4. Mary Adkins mentioned the use of a chair rail system with hooks after the building is painted to keep people from ruining the walls.
5. John Dockery – Whatsup247. Widget on websites that will spread information out to more individuals. Promote within the community events that are going on. Partnering with the Henry County Visitor's Bureau. No cost to the town. Subscription model: No cost for directory listing. \$20/month or \$200/year for unlimited events. Board approves to use Whatsup247.
6. Resignation of Clerk-Treasurer, Rayann Knepley. Last day will be 06/30/22. Will help with transition of new Clerk-Treasurer in Gateway, etc.


