## III. Approval of minutes from last meeting

## IV. Open issues

Paving/Patching Roads: Paving is complete. Grant recertification for North side
has been submitted. Town portion approximately \$37,000. Possible send a letter
requesting donations/pledges. Party with Kevin Stonerock (summer sometime).
Greensboro Methodist Church would like to work with the community to have a
party.

Need an interim fix to the potholes. Jason Clark would like to possible help with taking the millings. Possible take out a bond to help pay for repairs. May 14<sup>th</sup> – 8:00 AM at Community Building.

- 2. Police Department update. Chief would like to have an ordinance that sets the police department operation at no less than ten (10) years. Working hard to obtain grants. Brought up replating of roads Check for street signs. Stop signage needs checked, replace speed limit signs. Road painting (white line before stop sign, etc.)
- 3. Greensboro Community Fund. Thoughts on Easter egg hunt? Police Chief thought it went well. Thanked Mike Dawson for his monetary contribution. Board would

like to change administration of the GCF to someone who is in town and have it more properly managed.

### V. New business

- 1. South Side of North Street. Contact contractor to come out and check for flaws.
- 2. Zach Clark brought up about trees destroying road. Arbor Association will assist and provide new trees if the old ones are cut down on North Street. Possible to get Duke to cut some down (if they are in danger of power lines) or is it the responsibility of the property owner.
- 3. Parks Board: Appoint a new board to begin working on improvements around the building. John Runberg and Misty Clark would like to join.
- 4. Shaun Wilkinson. Fencing issue. Town would prefer he butt up to the stretch fence as opposed to cutting the fence.
- 5. Clerk-Treasurer. Contact Rayann if you would like to take over.
- 6. Police Department. Chief would like to have an ordinance keeping the police department set up for no less than 10 years. Community inputted that they wanted the police to go forward for at least 10 years. Board votes 2-0 to approve the ordinance.
