Month of May: 79 traffic stops, 79 warnings. 70 business checks, 94 patrol hours and 39.5 admin hours. Still working on town attorney.

National Night Out – September/October. Food, games, water balloon fight. Saturday evening. Possible fundraiser for the town. Cadiz Fire Dept willing to come out with trucks.


3. Greensboro Community Fund. Board will be having a private meeting with Kylie to see where the money is going and what her progress is.
