Minutes from the September meeting were read and same were approved by the board.

### **IV. Open issues**

1. Paving/Patching Roads: Paving is complete. Grant recertification for North side has been submitted. Town portion approximately \$37,000. Still waiting
2. Police Department update. Month of September: 128 patrol hours, 258 admin hours, 70 traffic stops, 64 warnings, 6 tickets, 66 business checks (churches, community buildings, etc.), 50 training hours.

National Night Out – September 17, 2022, 3:00PM to 7:00PM. 135-man hours. Chief felt it was a success. Great turnout. Hopes for bigger and better next year.

911 Board Meeting: September 21<sup>st</sup> at 10:00 AM. Approved to be on the 911 system. Still getting things together – fingerprints, etc. Allowed on the radios.

Fundraising Event at Culvers in Greenfield on September 20<sup>th</sup> from 5:00-8:00PM. 20-man hours. Chief felt it was a success. Still waiting on amount raised.

**January 1, 2023, hope to have 24-hour access. Hired more officers.**


3. Parks Board: Misty Clark has some plans that she will draw up and present next




