December 5, 2022

### **I. Call to order**

President Mikel Knepley called to order the regular meeting of the Town of Greensboro at 6:38PM on December 5, 2022, at Greensboro Community Building.

### **III. Approval of minutes from last meeting**

Minutes from the November meeting were read and same were approved by the board.

### **IV. Open issues**

1. Paving/Patching Roads: Grant recertification for North side has been submitted. Town portion approximately \$37,000. Spoke with Engineer. We should know this month whether we were approved. As of this meeting, we still haven't heard.

2. Police Department update. Patrol hours 108.75; training hours 109.50; Admin hours 64. Traffic stops 42; UTTs 8; warnings 34; business checks 46.

GPD assisted and helped Sheriff's office with traffic accident.

Traffic and Vehicle Ordinances approved. Clerk-Treasurer will submit to recorder.

3. Parks Board: No updates

4. Clerk-Treasurer. Job description is available. Contact Rayann if you would like to take over. Submitted resignation to Henry County Clerk. Democratic Party is looking for someone to replace.

5. Dead End sign at S. High Street and E Main Street. Town will move the dead in sign up higher. Jason Clark has a "No Outlet" sign and Larry Adkins has post.
6. Ordinances. Still working on.
7. Town drain on West Main Street has collapsed. Needs formed up and a grate added up. Possible grant to fix drainage issues. Will have to wait until Spring to fix.
8. Tree Lighting and Christmas Event. Thoughts on making it better next year? Move days closer to Christmas. Different advertisement.
9. Dwayne Estelle's white great dane. Verbal warning still needs to be given.
10. Budget approved. Town was approved for \$31,595 in General Fund, \$10,000 in MVH Fund and \$10,000 in LRS Fund. Copy available to review.

#### V. New business

1. Chuck Smith. Presented an agreement between him and Linda Cleek to close the alleyway. Mike and Mikel signed that they would honor the agreement. Ralph refused to sign the agreement as he did not agree with the closure.
2. Jennifer Smith. Has some old Greensboro photographs that she'd like to get reframed and will present it to the town to hang in the Community Building.




