January 9, 2023

I. Call to order

President Mikel Knepley called to order the regular meeting of the Town of Greensboro at 6:32PM on January 9, 2023, at Greensboro Community Building.

III. Approval of minutes from last meeting

Minutes from the December meeting were read and same were approved by the board.

IV. Open issues

- Paving/Patching Roads: Approved for the grant for North side. Working with INDOT now to sign all paperwork. Still need donations to cover town's cost of approximately \$37,000. Clerk proposed President overseeing all signing of documents with INDOT. Board approved
- 2. Police Department update. Patrol hours 160.5; training hours 59.50; Admin hours 78; Special Event Hours: 92.5 for a total of 400.5 hours. Traffic stops 48; UTTs 4; warnings 44; business checks 70. Dispatched runs 2. Assist Other Agencies 1.

Corp Caswell recognized as Officer of the Year

Lt Craighead and Sgt Thompson attended AAID Panel (Similar to MADD).

Officers completed 65.5 hours of Home Study online Web based LEO training.

GPD proposed to the board the use of Jason Clark's property as a "shooting range" to be used twice a year, one day for approximately four hours for training. Ralph opposed to shooting range as it affects the animals and shouldn't be that close to city limits. Board tables the discussion until March when weather is better and have a chance to survey the property.

Police will be ordering the speed limit signs (25MPH)/Reduce Speed Sign. Will get Clerk/Treasurer cost.

- Parks Board: Misty Clark submitted proposal for redesign of park. Found some organizations that could help with grant money. Town will need to submit proposals and letters. Misty Clark will get a cost assessment prepared.
- Clerk-Treasurer. Job description is available. Contact Rayann if you would like to take over. Submitted resignation to Henry County Clerk. Democratic Party is looking for someone to replace.
- 5. Dead End sign at S. High Street and E Main Street. Town will move the dead in sign up higher. Jason Clark has a "No Outlet" sign and Larry Adkins has post.
- Ordinances. Still working on.
- Town drain on West Main Street has collapsed. Needs formed up and a grate added up. Possible grant to fix drainage issues. Will have to wait until mid-to late Spring to fix.
- 8. Dwayne Estelle's white great dane. Verbal warning still needs to be given.

V. New business

- 1. Mike Dawson: Submitted resignation effective June 30, 2023. Will submit a formal written resignation.
- 2. Check into drain cleaning for the streets.
- 3. Town Lawyer: Isaac Trolinder out of Shelbyville. Rate will be \$150 per hour. No retainer needed.
- 4. Jason Clark: Vehicles in town rolling through late at night. Will give GPD description of vehicles allegedly involved in theft.
