March 6, 2023

I. Call to order

President Mikel Knepley called to order the regular meeting of the Town of Greensboro at 6:30PM on March 6, 2023, at Greensboro Community Building.

III. Approval of minutes from last meeting

Minutes from the February meeting were read and same were approved by the board (will sign at the next meeting – no ink in printer to print minutes for signature).

IV. Open issues

1. Paving/Patching Roads: Approved for the grant for North side. Working with INDOT. Need \$37,000 for town's portion.

Planning committee met February 20, 2023, and discussed events. Easter event on April 8, 2023, at noon will be free will (have a "donation" jar). Face painting is set up, corn hole, sack races, egg hunt and ice cream.

Continue to build events and get community involved. Greensboro Pike Festival and Summer Fest is in the process of being scheduled.

Next planning event meeting is March 22, 2023, at 6:30 PM at Community Building.

2. Police Department update. Patrol hours 251; training hours 35.5; Admin hours 123; Court hours 3; in-service hours 42.5 for a total of 455 hours. Traffic stops 77; UTTs 10; warnings 67; business checks 160. Dispatched runs 1. Arrests 1.

Inservice Training was conducted for the new updated statewide pursuit policy.

Cpl. Casswell assisted county with an overdose.

Lt. Craighead and Officer Aguilera assisted with two AAID panels.

Officers completed LETB required Inservice training online.


3. Parks Board: Misty Clark would like to submit to T-Mobile (submit proposal). GiveSendGo (like go fund me). Youtube – Non-Profit Site where we can post videos of wants and people can donate. How much do we want to spend and what kind of equipment do we want to get/replace. Walmart grant. Get out when it's warm (early-mid March) to measure, get grant letters sent out so we can see what type of money we can get.
4. Clerk-Treasurer. Job description is available. Contact Rayann if you would like to take over.
5. Ordinances. Still working on.
6. Town drain on West Main Street has collapsed. Needs formed up and a grate added up. Possible grant to fix drainage issues. Will have to wait until mid-to late Spring to fix. Issue put on hold for now. Board will meet on Saturday, March 11, 2023 at 11:00 AM
7. Mike Dawson: Submitted resignation effective June 30, 2023.
8. Check into drain cleaning for the streets.

V. New business

1. Emergency siren. Reach out to 911 Communication.
2. Town Board and Chief of Police agree that any ordinance violation fine paid, the sums split the money 50/50. Vote passed 2-0.
