- III. Minutes from July 2024 meeting were read and approved by the board.
- IV. Open Issues

- V. New Business discussed
 - A. Financial
 1. Board has not met with Morelock again to initiate contracting.
 2. Meeting scheduled to review PD 2025 budget, Aug. 14; 6:30pm at community building.
 3. Board asked for 1 member to put on the checking account. They need access in the event that CT becomes incapacitated.
 4. Comcast account does not reflect new contract.
 5. Elly expressed concerns over debit card fraud alerts causing cards to be cancelled & reissued. There have been 3 instances so far.
 - B. Building / Grounds / Park
 1. Additional key ordered & received from Rumpke for dumpster lock – provided to Mikel for renters to use. Second key that was previously received was located & Jason will maintain possession of it. The police department also has a copy.
 3. Signs still need to be put up in CB regarding thermostat setting &/or lock boxes may need to be installed.
 4. Jason advised of parts on mower needing to be replaced. He will purchase asap.
 - C. Streets / Zoning
 1. Paint needs to be obtained for road painting at stop signs
 2. Pickens suggested relocating a stop sign for better visibility.
 - D. Police
 1. Pickens advised the PD has their own EIN now & is now a separate government entity.
 2. PD is applying for 501c3 status.
 3. Advised to verify tax exempt status for town via IRS.
 4. UTV stop completed in July was determined to be lawful.
 - E. Citizens Concerns
 1. The Methodist Church will be holding a yard sale on Sept. 14
 2. The Nazarene Church will be holding a concert & special events for their 100th Anniversary on Sept. 14 & 15.
 3. The Historical Underground Railroad sign at the Nazarene Church parking lot needs repair.






